

Website Privacy Policy

This privacy policy has been created to better serve those who are concerned with how their 'Personally Identifiable Information' (PII) is being used online. PII, as described, is information that can be used on its own or with other information to identify, contact, or locate a single person, or to identify an individual in context. This policy is in line with *General Security Policy of Yamamah University*. Please read the privacy policy carefully to get a clear understanding of how YU collects, uses, protects or otherwise handles your PII in accordance with the YU website/mobile app.

Personal identification information

YU may collect personal identification information from Users in a variety of ways, including, but not limited to, when Users visit our YU website/mobile application, fill-in a form, open a support ticket in connection with other activities, services, features or resources YU makes available on the YU site/mobile application. Users may visit the YU site/mobile application anonymously. YU will collect personal identification information from Users only if they voluntarily submit such information to us. Users can always refuse to supply personally identification information, however, that may prevent them from engaging in certain mobile application related activities.

Non-personal identification information

YU may collect non-personal identification information about Users whenever they interact with the YU site/mobile application. Non-personal identification information may include the browser name, the type of computer, and technical information about Users' means of connection to the YU site/mobile application. This includes the operating system and the Internet service providers' utilized, as well as mobile device information (any mobile device used to connect YU website/ mobile application, may include mobile phone/ iPad etc.).

Web browser cookies or similar technologies

Al Yamamah University's site/mobile application may use cookies or similar technologies to enhance User experience and compile aggregate data about site traffic and site interaction so that YU can offer better site experiences and tools in the future. A User's web browser places cookies on their hard drive for record-keeping purposes and sometimes to track information about them. Users may choose to set their web browser to refuse cookies, or to alert when cookies are being sent. If they do so, note that some parts of the YU site/mobile application may not function properly.



How YU uses collected information

Al Yamamah University's website/mobile application may collect and use Users' personal information for the following purposes:

- 1. Run and operate the Site & mobile Application with a better and improved environment, and
- 2. Conform security policies of YU/ the local laws/ national security policies to address other unforeseen legal issues.

Information Security

YU adopts appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of your personal information, username, password, transaction information and data stored on the YU website/mobile application.

Sharing your personal information

Al Yamamah University does not sell, trade, or rent Users' personal identification information to others. YU may share generic aggregated demographic information not linked to any personal identification information regarding visitors and users with YU business partners, trusted affiliates, sponsors, and advertisers for the purposes outlined above. YU may use your information in order to contact you for the purpose of marketing/ sharing news of YU or some other literature. If you do not want to have this marketing information, you can contact us to decline to participate. Your personal information will not be shared with anyone, except if law enforcement agencies require your personal information.

This Privacy Policy governs the manner in which YU collects, uses, maintains and discloses information collected from Users (each, a "User") of the http://www.yu.edu.sa website ("Site").

Changes to this privacy policy

Al Yamamah University may revise these terms of service for its website/mobile application at any time without notice. By using this website you are agreeing to be bound by the then current version of these terms of service.
